A. GENERAL

1. The promotion is offered by **Blueberry Markets**, a company providing trading in financial and commodity-based derivative instruments and other securities. Blueberry Markets (Mauritius) Ltd (Company Number 218548) holds a Global Business Licence GB24203929 under the Financial Services Act, allowing it to be a Full Service Dealer (excluding underwriting). Blueberry Markets (V) Ltd is regulated by the Vanuatu Financial Services Commission (Company number: 700697), holding License Classes A, B and C under the Financial Dealers Licensing Act.
